

The attached Employment Contract covering the period March 1, 2012 – June 30, 2013 is hereby amended as follows:

2. TERM - The term of this Contract is for two years commencing July 1, 2013 through June 30, 2015. The Superintendent and the Board Certified Analyst Supervisor provided either has notified the other in writing of their desire to commence negotiations for a successor agreement, will endeavor to reach agreement on a successor contract on or before July 1, 2014. For purposes of this Agreement, the anniversary date shall be considered to be July 1 of each year.


