**NEW INSTRUCTIONS for issuance of this year's (FY '22) Green Lodge Street parking stickers:**

Out of an abundance of caution to follow proper protocols to stop the spread of the COVID-19 virus, we are offering parking stickers to be sold through a **mail-in process or a random drawing process**, as follows:

- Applications are now available:
  - On the Town of Canton's website; at the Collector's counter at Memorial Hall; and
  - On the table in the vestibule of the Sherman Street side entrance of Memorial Hall between the hours of 8:00am to 5:00pm Monday through Thursday; until 7:00pm on Thursday evenings; and 8:00am to 1:00pm on Fridays.
- All applications with required documents must be mailed to the address at the top of this application, or dropped off at the Collector's office or in the payment drop box in front of Memorial Hall, clearly marked on the outside of the envelope "Green Lodge Street Parking";
- Include your check made out to the **Town of Canton** for the proper amount, a copy of your registration and this completed and signed application form;
- ❖ All fields are required to be completed;
- The parking sticker fees are unchanged: (3) three months at \$130.00; (6) six months at \$230.00; and (12) twelve months at \$400.00;

- Applications for first consideration will be received at Memorial Hall from 5/12/21 – 6/11/21;
- Applications will be accepted until Friday June 11<sup>th</sup>;
- All sealed applications will be held unopened in a secure location until Monday June 14<sup>th</sup>;
- On Monday June 14<sup>th</sup> the number of envelopes received will be counted:
  - If less than 125 envelopes are received, all applicants will receive their requested parking sticker;
  - If 125 or more envelopes are received, on the afternoon of June 15<sup>th</sup> the Town Clerk will conduct a random drawing of all envelopes which are each boldly labeled as drawn “1, 2, ...150, ..200, etc.”.
    - A zoom access viewing is posted allowing interested parties to witness the Town Clerk drawing remotely.
    - Once all envelopes are labeled in sequence of being drawn, the parking stickers will be awarded by the Assistant Treasurer/Collector based on the lowest numbers drawn until all stickers are gone;
- If a shorter duration sticker than requested is awarded, the applicant will be contacted to arrange for a reduced payment;
- Checks will be returned for any unfilled requests;
- Incomplete applications, (no check, no copy of registration, or unclear form) will not be eligible;
- Stickers will be mailed out in time for July 1 use and could also be picked at the Collector’s office beginning on June 21<sup>st</sup>.

If necessary, I authorize designees of the Town of Canton to research my motor vehicle registration information on the Massachusetts RMV database. I agree and acknowledge that use of the Green Lodge Street parking area is subject to area use guidelines which, from time to time, may be modified by the Town of Canton, inclusive of any waiver of liability.

In exchange for good and valuable consideration, the receipt and sufficiency of which the purchaser of the Parking Permit (the “Purchaser”) hereby acknowledges, the purchaser, on behalf of him/her self, his/her successors, heirs, administrators, executors, assigns, agents, representatives, attorneys and all those in privity with him/her hereby releases, forever discharges and agrees to indemnify the Town of Canton (“The Town”) and all of its present and former officers, directors, shareholders, employees, trustees, servants, agents, representatives, successors, subdivisions, affiliates, heirs, administrators, assigns and beneficiaries of and from any and all claims, charges, complaints, causes of action, demands, obligations, liabilities, damages, demands or accounting, inspections or declarations, attorney’s fees, expenses, interest and costs of any kind and in any form whether administrative, judicial or other concerning the purchaser’s use of the Town Green Lodge Street parking area.

I acknowledge and agree to all current parking program requirements and my commitment to fully adhere to the program and parking requirements. Further, I agree to any parking program requirements which, from time to time, may be changed, modified or otherwise enhanced.
